#### DIRECTIONS FOR USE

Read entire label prior to use and use product as directed. Shake well before use or dilution. Spray surfaces to be treated from a distance of 8-12 inches, directly spraying listed pests. Use 2-4 trigger sprayer pumps, depending upon pest pressure, and thoroughly wet listed pests, but not to the point of saturation/runoff.

Directly contact insects on structures, in cracks and crevices and in plant/flower beds. For best results apply every 3-4 weeks, or more frequently depending upon pest pressure. Thoroughly wet pests, but do not oversaturate.

To kill fleas and ticks in your lawn, mow your lawn a day or two before spraying. Then spray in a slow, even sweeping motion, and be sure to cover the entire lawn surface where your pet normally goes. Spray under trees and ornamentals but avoid soaking young or flowering plants.
