## DIRECTIONS FOR USE

Read entire label before use. Shake well before use.

To control listed pests in your carpets and upholstery, uniformly apply powder over the entire surface. **Apply only to dry surfaces and do not wet powder.** Prior to general application test a small, inconspicuous area and check later for effects on color (staining) or texture. Apply in and around areas where insects may be crawling, hiding or living. The amount to apply varies depending upon infestation severity. Suggested application rate is 1-2 oz per 100 sq ft of surface area. Apply more powder to areas where pets spend most of their time. Focus heavier treatments to areas where dogs land as they jump off beds and to higher elevation resting areas. Regularly dust pets' bedding, kennel and sleeping areas. Reapply every 2-11 weeks, as needed, to control infestation. May be used year-round to help reduce the occurrence of fleas and ticks. If powder adheres to a spot, immediately brush out and remove with a vacuum. Empty vacuum bag, outdoors, after each use. For added control, simultaneously treat pets with a flea and tick control product labeled for use on pets, before entry into treated areas.

**Carpets:** Brush lightly with a broom to force powder deep into carpet where fleas and their larvae exist. Wait at least one hour before lightly vacuuming to remove powder visible on carpet surface. For maximum efficacy, and when applying at lower rates, delay vacuuming for 24 hours.

**Upholstery:** Remove loose cushions. Sprinkle along creases and into corners. Use a brush to lightly work powder into folds and creases.

**Carpet Edges and Furniture:** Powder may also be applied under the edges of carpeting around the tack strip that holds the carpet tight against the walls. For bed bugs, additional areas may be treated such as the cracks of bed frames, headboards and other furniture. Wipe away excess dust with a damp cloth to ensure your applications are inaccessible to future human/pet contact. Do not apply this product into electronic equipment (TVs, radios, computers, etc.).
